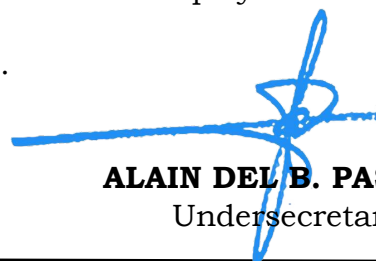
Designated Administrators of the DepEd Mobile App are reminded of some urgent tasks/responsibilities. All are advised to check, review and implement the following:

ANNEX A: DEPED MOBILE APP ADMINISTRATOR'S GUIDE

1. Approve pending facility tracker users in the pending approval tab with the following criteria:
 - i. Remember that NOT ALL DepEd teachers are DepEd Mobile App Facility Tracker Users. Therefore, ensure that you are verifying the officially assigned SST / DRRMO via-s-vis the school.
 - ii. Make sure that the users in the pending approval have registered with their deped.gov.ph email accounts.

2. If the user is verified SST (single source of truth) or DRRMO with deped.gov.ph email account, APPROVE.

If the user is not a DRRMO / SST User, regardless if they have registered with a deped.gov.ph email account, REJECT

3. If the user is a verified SST (single source of truth) or DRRMO but did not use their deped.gov.ph account, PLEASE create and activate their deped.gov.ph email accounts. Then request for them to sign-up again using the deed.gov.ph email.

ONLY then, the users can sign-up to use the mobile app account, when they have confirmed their account via email and you have approved their registration via your admin dashboard at the pending approval tab.

4. Logs and reports of approval of users are available so it is imperative that we take note of the tasks at hand to ensure that users are able to maximize the potential of the DepEd Mobile App-Facility Tracker.
5. To further, maximize your access, go to Facility Trackings. This menu gives you a list view of schools categorized as:

- i. In Utilization. Lists all schools that are currently used during this Covid-19 situation.
- ii. LGU Requested. Lists all schools which have been requested for use.
- iii. Not Used. Lists all schools which are not in use.
- iv. All. Lists all schools regardless of utility.

At the bottom left of these list views, you can get an offline version of the day's report by clicking "Download: CSV". Once downloaded, you can open the file using your spreadsheet application (e.g. Excel, Calc Spreadsheet Numbers)

Subject: **DEPED COVID-19 MONITORING APP SIGN UP PAGE**

To facilitate ease of access and to resolve issues regarding incorrect passwords and difficulties in logging-in to the DepEd COVID-19 Monitoring App, a user sign up page has been deployed into the system. All pre-registered Single Sources of Truth (SSTs) at the school level are instructed to follow these instructions:

1. Go to https://mobileapp.deped.gov.ph/users/sign_up and enter your active email address, full name, contact number, school information, and password.
2. Your email must contain the domain @deped.gov.ph. All SSTs who do not have a DepEd Email account may use their personal email but are required to coordinate with their local IT officers for the issuance of a DepEd email account.
3. Check your email for "Confirmation Instructions", click "Confirm my account", and wait for the "Welcome to DepEd Mobile App" approval email within 24 hours.

ANNEX A: Common Issues

A number of preregistered designated Single Sources of Truth (SSTs) are still unable to access the DepEd Mobile App. One of the main culprits is that the email used to login is not the preregistered email. This problem has variations, too, such as:

1. Typographical errors in the email (e.g. juandelacruz@deped.giv.ph);
2. Invalid email address (e.g. juandelacruz@deped.com.ph); and,
3. Alternative email specified (i.e. user is logging in using DepEd email but had pre-registered using personal email).

Other issues include:

1. Installation Error for Android due to Security Concerns

For those who encountered problems on installing the Android app due to security concerns, be assured that we are working closely with Google Play to resolve the issue.

2. Invalid Passwords

The teams has already implemented the new sign up page so that users can already nominate their own password.

3. Poor Internet Connection

While this issue is beyond the team's capacity to resolve, please collaborate with you co-SSTs who have better internet connections in order to update your school's status reports.

Subject: **REGISTRATION OF SINGLE SOURCE OF TRUTH AT THE SCHOOL LEVEL**

To assist the Department of Education (DepEd) Task Force COVID-19 in collecting data and reports from the field, the Office of the Undersecretary for Administration (OUA) is enjoining the identification and registration of Single Source of Truth (SST) at the school level and may be composed of the following:

- School Principal or School Head;
- Health and Nutrition Coordinator;
- Clinic Teacher;
- DRRM Coordinator; or,
- a Team of 2-3 School Teachers and Employees.

The designated SST personnel of their school are expected to provide status reports such as:

- Status of school facilities;
- Status of school personnel and learners' health; and,
- Status of services rendered during the community quarantine period.

SSTs shall use the DepEd Mobile Monitoring Apps for this purpose. Designated SST per school will need to enlist at <http://bit.ly/DepEdSSTRegistrationForm> on or before **12:00 Noon of April 8th, Wednesday, for pre-registration of users.**
